This agreement and the relationship of the parties will be interpreted in accordance with the laws of the State of Indiana and the Buyer consents to jurisdiction of Indiana courts and the venue in Vanderburgh County, Indiana.

The Buyer recognizes that Complete Lumber, Inc. has and may exercise its rights under the mechanic's lien laws in Indiana or Kentucky. The Buyer further grants to Complete Lumber, Inc. a security interest in the Buyer's equipment, contract rights, inventories, receivables and proceeds of sale as collateral to secure the Buyer's performance of all obligations to Complete Lumber, Inc. The Buyer further authorizes Complete Lumber, Inc. to file a financing statement without Buyer's signature. The Buyer will do no construction work under a no-lien contract and will indemnify Complete Lumber, Inc. against any damages if Complete Lumber, Inc. is requested to provide materials for a no-lien contract project. The undersigned individual or officer is empowered to execute this application and agreement and affirms that the information contained herein is true and correct. Acceptance of this application poses no obligation on Complete Lumber, Inc. to extend credit.
